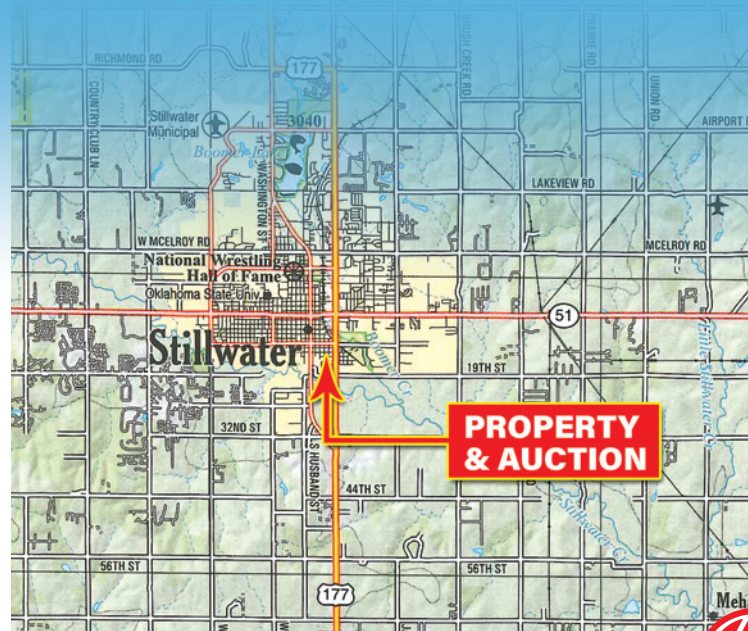

REAL ESTATE TERMS & CONDITIONS:
