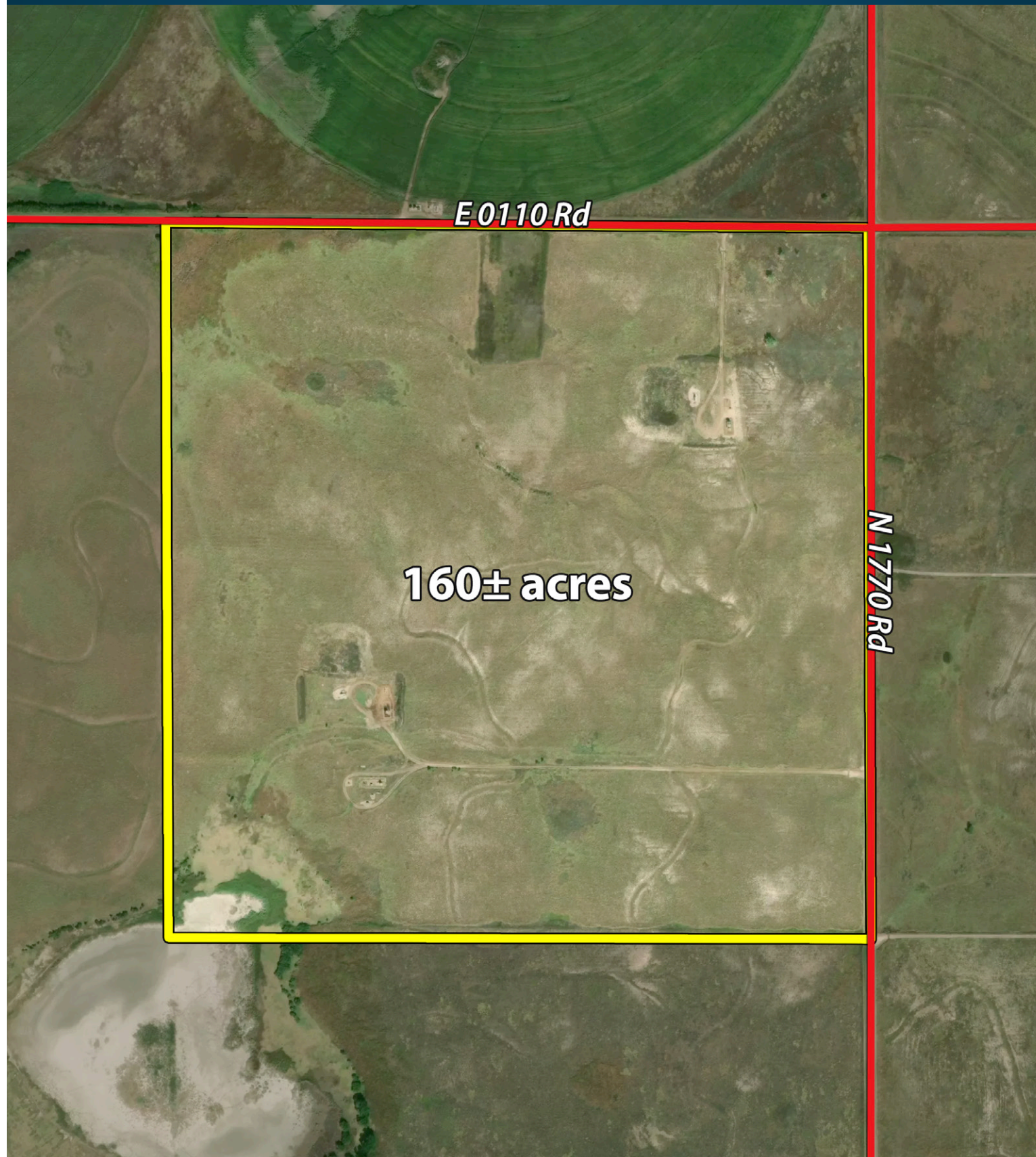

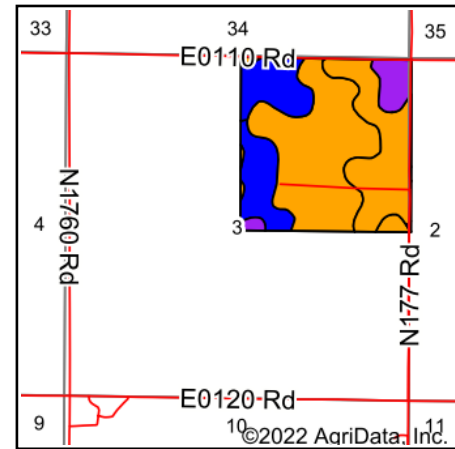
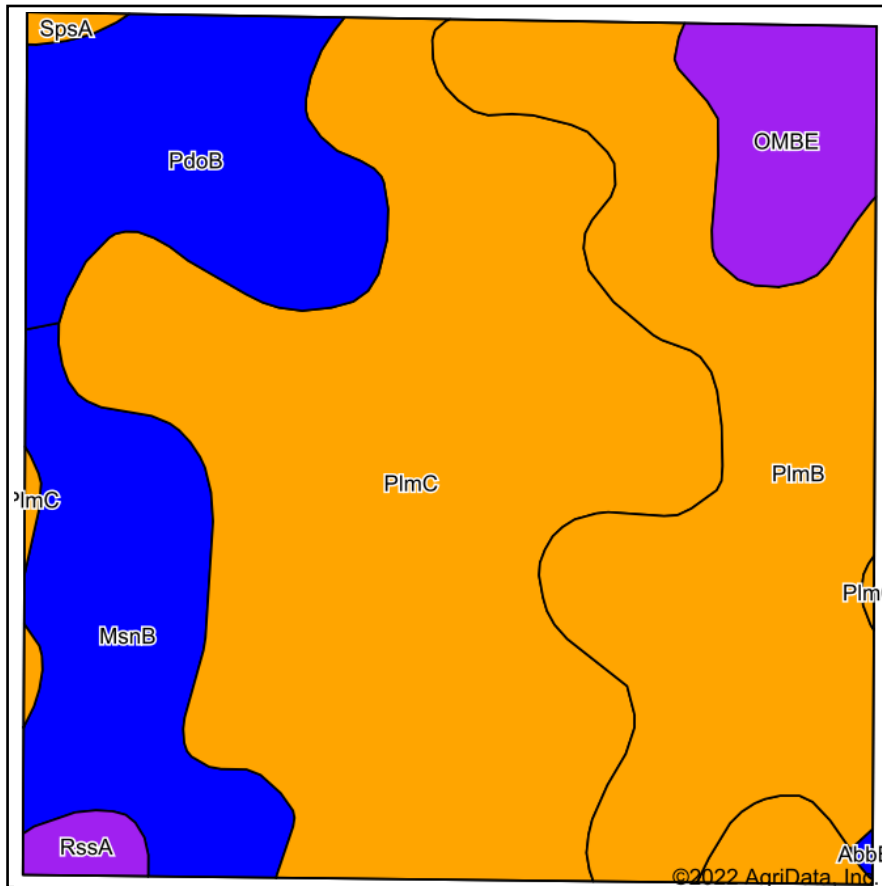


# LOCATION MAP

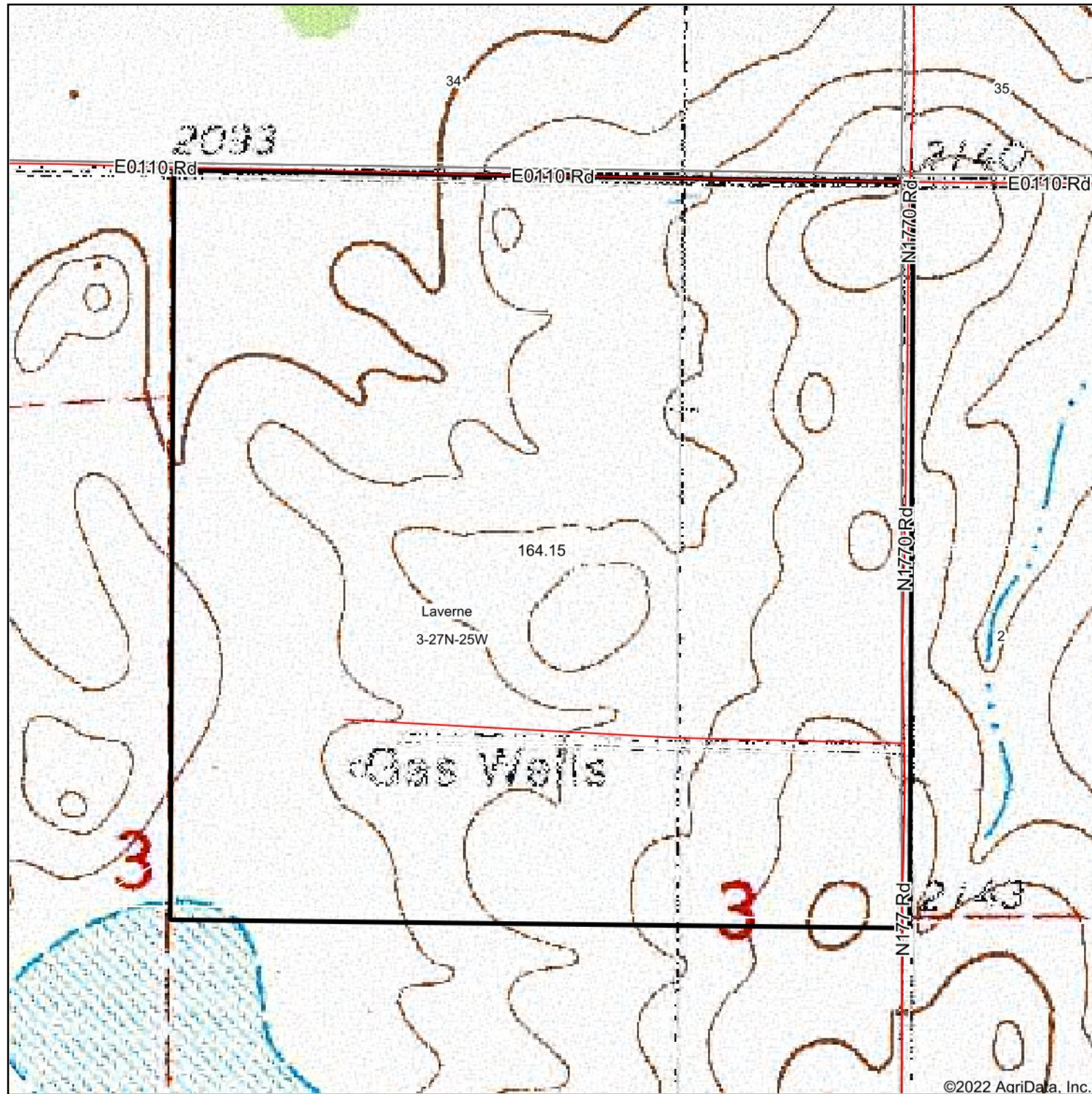

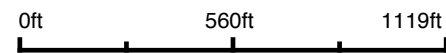
