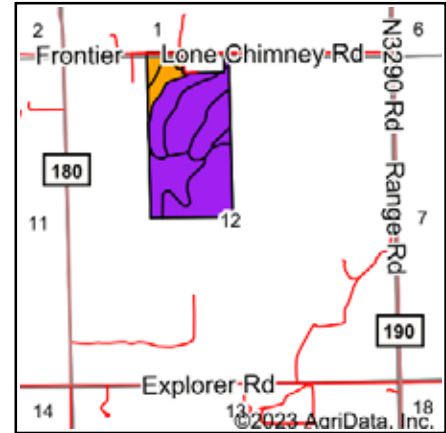
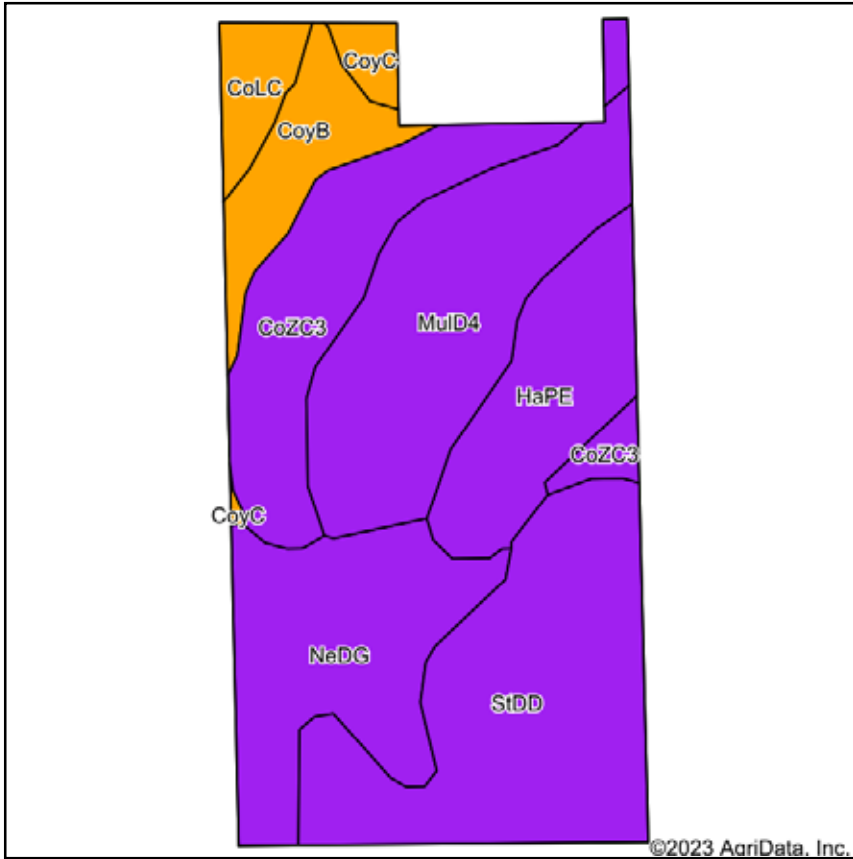


LOCATION & TRACT MAPS

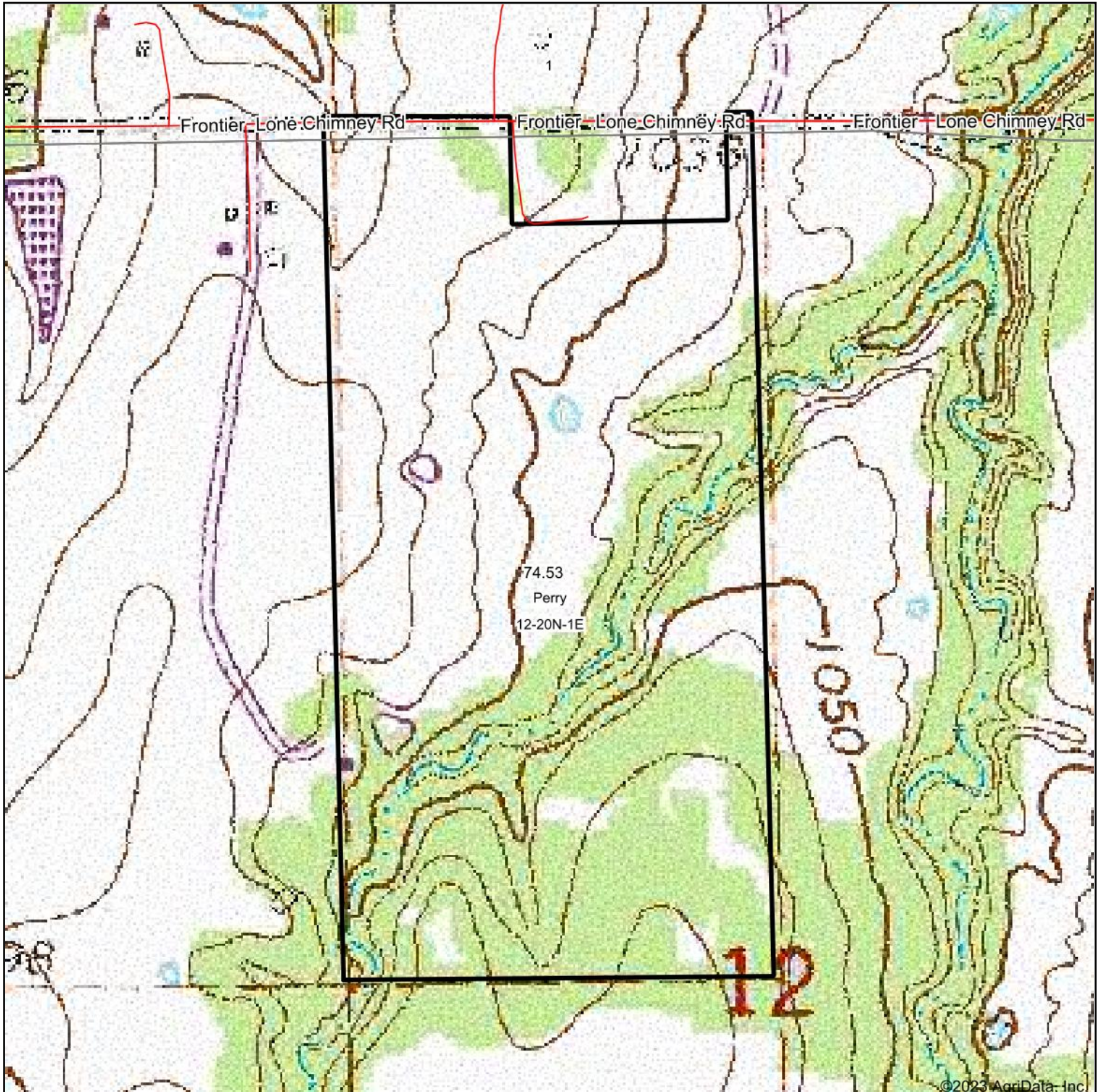
